OBJECTIVES OF ANZLAA

The Australian and New Zealand Laboratory Animal Association is made up of members with a professional commitment to the care, production and use of animals in research and teaching in Australia and New Zealand. Through the conduct of its activities, the Association shall seek to promote:

- (a) High standards of husbandry, health and care for animals used in research and teaching.
- (b) High ethical conduct in research and teaching involving the use of animals.
- (c) The exchange of information within the research and broader community relating to animals used in research and teaching.
- (d) Co-operation between organisations and institutions associated with the use of animals in research and teaching.
- (e) The development of alternative techniques to the use of animals in research and teaching.
- (f) All such other things as are incidental or conducive to the attainment of the Objects of the Association.

MEMBERSHIP POLICY FOR 2009

Benefits to be conferred by membership:

- Access to the email bulletin board
- Notification of meetings and events
- Discount conference registration
- Access to members-only pages on the ANZLAA web site
- Voting rights (except Corporate and Affiliate Members)
- Eligibility to apply for ANZLAA-sponsored programs, scholarships etc

Membership criteria:

Ordinary Membership. Ordinary Membership is open to individuals who are employed or otherwise engaged (including on a casual basis) in a part-time or full-time position relevant to the Objects of the Association.

Student Membership. Student Membership is available to individuals enrolled in full-time or part-time study in a field relevant to the Objects of the Association. Student Members must be residents of Australia or New Zealand.

Institutional Membership. Institutional Membership will not be offered for 2009.

Corporate Membership. Corporate Membership is available to businesses whose activities are relevant to the Objects of the Association. Organisations holding Corporate Membership will be entitled to have their names listed on the ANZLAA website along with a link to their homepage and a summary of their products or services (maximum of 25 words with wording subject to Committee approval). Corporate Members must nominate a contact person. Corporate Membership does not confer voting rights but individuals within organisations holding Corporate Membership may take up Ordinary or Student Membership if they meet the usual criteria applicable to these categories.

Life Membership. Membership in this category may be bestowed upon individuals whose contribution towards the goals of ANZLAA is widely recognised as outstanding. Admission to this category is only available through nomination by an ANZLAA member belonging to either the Ordinary or Life Membership categories. Decisions regarding admission to Life Membership shall be made by the Committee. Life Members or Fellows of AATA, ASTA and ANZSLAS shall be granted automatic Life Membership of ANZLAA.

Affiliate Membership. Affiliate Membership may be bestowed on individuals or organizations not eligible for membership under any other category and whose professional interests are consistent with the Objects of the Association. Organisations belonging to this category may, subject to approval by the Management Committee, have a link to their organisation's home page on the ANZLAA website.
